

WHAT IS THE SIE® EXAM?

THE FINRA® SIE® exam is for prospective securities industry professionals. This exam assesses a candidate's knowledge of basic securities industry information including concepts fundamental to working in the industry, such as types of products and their risks, the structure of the securities industry markets, regulatory agencies and their functions, and prohibited practices.

The SIE® exam is open to anyone age 18 or older, and the results are valid for 4 years.

SCC offers two certificate programs that can be completed in as little as one semester, to help prepare students for the Financial Industry Regulatory Authority [FINRA®] SIE® certification exam and for employment in the financial services sector.

These programs will prepare students for a wide variety of entry-level positions in the financial service and securities industries.

The 4-credit Financial Services: Pre-Licensure program is for those who already have a degree or significant work experience, as this certificate solely focuses on the SIE® exam.

The 16-credit Financial Services program is for students new to higher education and the business world. In addition to preparing for and taking the SIE® exam, students learn professional skills and develop a strong foundation in fundamental concepts needed in the securities industry.

CAREER OUTLOOK

Entry-level finance jobs earn an average of \$59,184 a year.* Robert Half Inc. projects entry level annual salaries in finance to range from \$56,375 to \$74,525 in the Phoenix metro area.** This compares favorably to national salaries.

The median individual income was \$40,480 in 2022, according to the U.S. Census Bureau. The Bureau estimates that the number of financial jobs will increase by 9% between now and 2028, which is faster than the average for all occupations.***
