GENERAL BUSINESS AT SCC

Scottsdale Community College (SCC), accredited by the Higher Learning Commission, offers the Certificate (CCL) and Associate of Applied Science (AAS) in General Business for students who wish to pursue business as a career. These programs are designed to meet the needs of students who do not want to enroll in a specialized business curriculum, but instead want to create their own area(s) of focus. In the certificate program, students take a core set of classes to improve their understanding of business vocabulary, workplace skills, and business decision making and select their own areas of business to study.

In the degree program, students also complete general education courses to build a well-rounded credential that can qualify them for a variety of industries. Students who earn the Associate of Applied Science in General Business also earn the General Business CCL.
